

# Core of Knowledge Training Courses 2010 - 2011

For Clinicians and other staff using IPL or Laser Systems

**This course is intended for IPL or laser operators and other staff in Clinics using Intense Pulsed Light systems or lasers for hair removal, skin rejuvenation, vascular treatments, tattoo removal and other similar procedures. It is designed both to provide a grounding in the basics of the safe use of lasers / IPLs, and to satisfy the training requirements of the Healthcare Commission.**

- Eye and skin and exposure
- Precautions to keep exposure below maximum permitted levels
- Reflection and Absorption hazards
- Hazards to Patient
- IPL / Laser Safety Management
- Risk assessment / Incidental hazards
- Relevant standards
- Quality Assurance
- Equipment management



The course is based on the recommendations contained in the "Guidance on the safe Use of Lasers in Medical and Dental Practice" (MDA DB9602) and will cover the 'Core of Knowledge for Laser Users' defined in Appendix C of the Guidance. It will include the following topics:

- IPL / Laser Radiation Characteristics
- Radiation generation
- IPL / Laser radiation – tissue Interaction



By concentrating on these aspects the requirements of Standard P2 of the Independent Healthcare National Minimum Standards will be covered.
